We are working with DNR to get a permit to use a specific section of land that has a bridge for Rope Rescue training.

Green Diamond provided their 2024 Fire Plan.

We applied for a DNR 50/50 grant which helps provide for wildland gear and already picked up our order.

Our Temporary Summer Hire Position was offered and accepted by Tim Havnar. He will be on our calendar from May 12-September 12, 2024

The propane tank in Hoodsport was replaced 4/9/2024.

Had a conversation with District 17s Chief Brown and Brinnons Chief Manly on how to best support the area.

Firewise is building a shed behind Station 18-1 to store equipment and do community education on firewise practices and construction.

We got our radios in that are digital capable.

We had our annual pump testing, there is some work that needs to be done and we are working through scheduling that.

Our Brush Trucks have been de-winterized and the snowplow was removed.

Moving forward, Chief will be involved with the LCMC winter/plow planning meetings.

We are starting a book loaning program. Topics will include growth and development both personally and professionally.

Our State Auditors Report has been started and is being actively worked on. It is due by May 29, 2024.

We will be having a community CPR event June 1, 2024.

Good of the Order:

We recently had 6 students finish EMT class and have 2 more in class. They are all working through different stages in the testing. Approximately one-third of our roster are IV techs, and Jacee just finished the requirements to be a paramedic. The continued growth and number of responders on our roster that are certified is exciting for our community.
