- Skokomish Contract was signed 11/9/22 by all parties with an effective date of January 1, 2022.

As to what the Commissioners would like to see itemized: Donation of \$500.00 or higher, Ambulance Services, Fire Control Services, Cost Recovery and anything else that would be beneficial in tracking for the budgetary reasons.
