Hoodsport Fire & EMS March 8, 2023, Regular Meeting Minutes: Commissioner Weaver moved to accept, 2<sup>nd</sup> by Commissioner Bodin. Passed Unanimously.

Treasurer's Report/Payment of Bills and Payroll:

Total of \$145,115.46 bills and payroll for the month of February.

\$89,252.72 in EXPENSE

\$55,862.74 in EMS

Motion to pay the bills and payroll made by Commissioner Bodin. 2<sup>nd</sup> by Commissioner Lucas. Passed Unanimously.

Resolution 2023-08 to authorize the transfer of \$55,862.74 from EMS to EXPENSE to cover the EMS portion of the bills for the month of March. Motion by Commissioner Weaver, 2<sup>nd</sup> by Commissioner Lucas. Passed Unanimously.

## **Chiefs Report:**

- 47 calls in March, bringing us to 128 for the year.
- 37 transports this year
- We had to Auxiliary sponsored Easter Egg Hunt on April 8<sup>th</sup>, it was a huge success, thank you to the auxiliary for their time and effort, they stuffed approximately 3,500 eggs
- There was a DNR Open House attended by Michael Sexton and Ron Satterfield to get ready for the upcoming Wildland Fire Season. Karen Thomas attended the financial portion.
- Banking: Columbia Bank is now Umpqua bank

- A Dog Park was created in the space that is utilized as a Landing Zone. We are working with DEM
  to ensure that Landing a helicopter and life safety is maintained as a priority for that space, for
  both patients and crew.
- Chief Sexton is currently enrolled in an Instructor Methodology class through the end of May.

### Old Business:

- Snure Video link on Volunteer Programs was received and can be forwarded to any commissioners interested in watching it.
- Resolution 2023-04: Michael Sexton declining a 2023 wage increase. Motion by Commissioner Cochran. 2<sup>nd</sup> by Commissioner Weaver. Passed Unanimously.
- Commissioners will need to discuss and come to a decision on pay limits to each of the positions at the department to maintain viability of the department and its budget.
- Resolution 2023-05: As noted in last month's meeting, there was a contract discrepancy with
  Joseph Hills contract that said he would receive a raise in January, when it was intended to be
  July, at the end of his probationary period. Because our contract states January, we are honored
  that and gave his back pay for January and February. Motion made by Commissioner Bodin. 2<sup>nd</sup>
  by Commissioner Lucas. Passed Unanimously.
- Resolution 2023-06: Adjustment was made to our pay policy. Previously, based on our reference numbers, volunteers were able to earn up to, but not exceed, \$1200.00 per month for calls, transports, duties, drills, and shift. Based on Total Cost Calculation, that number was adjusted to volunteers are now able to earn up to, but not exceed \$1000.00 per month for calls, transports, duties, drills, and shifts. This was also updated in our "At-Will Volunteer Agreement". Motion by Commissioner Cochran. 2<sup>nd</sup> by Commissioner Weaver. Passed Unanimously.
- Resolution 2023-07: The relationship of volunteers to the department is mutually understood and agreed that it is an At -will volunteer agreement with an incentivized reimbursement schedule, and that can be terminated at any time by the volunteer or District for any reason. Motion by Commissioner Bodin. 2<sup>nd</sup> by Commissioner Lucas. Passed Unanimously.
- Reminder: Public Disclosure Commission submissions for Commissioner are due soon.
- Reminder of the Open Public Meeting Act requirements for Commissioners.
- There was a deposit error from the county, so the financial report for March was incorrect. The county made the corrections and they will be reflected in Aprils financial statements.

### **New Business:**

- Discussion was had on who all should be reflected on our VFIS insurance, decision was made for all paid staff and volunteer responders. Motion made by Commissioner Bodin. 2<sup>nd</sup> by Commissioner McDougall. Passed Unanimously.
- Website: We are switching to Streamline and have been working with them to get all our information transferred from the former website through Squarespace.
