#### Previous Minutes:

Treasurer's Report/Payment of Bills and Payroll:

- Total of \$105,384.35 in bills and payroll for the month of September.
- \$100,084.72 in EXPENSE
- \$5,299.63 in EMS

Motion to pay the bills and payroll made by Commissioner Cochran. 2<sup>nd</sup> by Commissioner Bodin. Passed Unanimously.

Resolution 2022-14 to authorize the transfer of \$5,299.63 from EMS to EXPENSE to cover the EMS portion of the bills for the month of September. Motion by Commissioner Bodin, 2<sup>nd</sup> by Commissioner Lucas. Passed Unanimously.

### Chiefs Report:

- Reviewed Monthly County Financial Statement.
- Tour of the station: The building is almost done being painted as approved by the commissioners. Also our new compressor fill station, that we got with a FEMA grant, at the Lake Cushman station was installed.
- 61 calls in August, brings up to 434 for the year at the end of August. Approx. 50 less than last year at that same time.
- We provided letters of support to PUD 1 for a grant for Comprehensive Vegetation Management and Mason County DEM for CWPP Community Wildfire Protection Plan.
- Commissioner Weaver has taken on the project of looking for what type of AC system that
  would work the most efficiently for the Lake Cushman station. He had one company out that
  said they could use some of our equipment to help cut costs, for the 3 "zones" in the building,

- and a 1-year maintenance. Their quote was \$61,906.80. We will revisit this later, looking at other options and getting other bids.
- Glenn: Interim GM at LCMC. Here to introduce himself. Talked about some projects they are
  currently working on including looking into some grants for helping with getting hydrants, trying
  to get a front end loader to help with clearing roads in case of snow etc, and a snow and ice
  plan; as he has previous Emergency Manager experience that will help make that project
  successful.
